

Confluence Cottages Rental Application

Application Instructions:

Complete the entire application. Applications are placed in order of the time and date they are received. If you have any questions or need assistance in completing the application, please contact the Housing Authority of Southeastern Utah. Management reserves the right to request additional information to ensure the application is complete.

Criminal and personal background checks will be completed on each applicant. Applicants will be approved or denied based on the results of these checks. Applicant delays in obtaining the requested information may affect your position on the waiting list.

Gross monthly income should equal 2 times the monthly rent or the applicant shall provide other documentation proving ability to pay rent. Income limits apply.

Applicants may be rejected based on negative previous landlord references and criminal background.

QUALIFICATIONS & INFORMATION

- Applicants will be considered regardless of race, color, creed, religion, sex, national origin, ancestry, marital or familial status, disability, source of income, gender identity or sexual orientation.
- Applicants must meet income guidelines. Inquire with the office.
- Rents: 1-bedroom: \$1,375/mo.; 2-bedroom: \$1,690/mo.
- Gross monthly income should equal 2 times the monthly rent or the applicant shall provide other documentation of how rent will be paid.
- HASU will consider previous landlord references, income, employment history, and criminal background history when screening potential tenants.
- Background check will cost \$35.00 and payable to "HASU"
- Individuals who are currently engaging in the illegal use of a controlled/illegal substance need not apply.
- Confluence Cottages are a non-smoking facility.
- The required security deposit is \$1,000 for 1-bedroom units and \$1,200 for 2-bedroom units.
- PET FRIENDLY with additional deposit.
- Water, sewage and trash are covered in the rental amount. Tenant responsible for Electric & Internet. Emery fiber access provided.
- Stackable washer/dryer provided.

- **Picture form of identification - State Driver's License or Identification card for all members of the household over 18 years old.**
- **Most recent pay stubs for employment or recent income verification for any earned/or unearned income.**
